

SAMSUNG BESPOKE REFRIGERATOR PANEL OFFER TERMS AND CONDITIONS

Offer description. Purchase an eligible Samsung Bespoke refrigerator from a participating retailer in-store or online (“Qualifying Purchase”) and receive a Samsung Credit to purchase Bespoke Refrigerator Panels (est. up to \$430).
