

SAMSUNG HOME APPLIANCE BLACK FRIDAY LAUNDRY PAIR OFFER TERMS AND CONDITIONS

Offer description. Purchase a qualifying Samsung Washer and Dryer with a pre-tax purchase price of \$1,396 or more (see Appendix A for list of eligible products) from a participating retailer and receive a \$100 Samsung Prepaid Mastercard® (after submitting valid offer claim as described below).
